URGENT: DRUG RECALL

**RE: Atorvastatin Calcium Tablets, 10mg
(Lot # 2407255 and 2407256, Expiry date: May, 2014 for both the lots)

Dear Valued Customer,

This is to inform you of a product recall being conducted voluntarily by Ranbaxy for Atorvastatin Calcium Tablets, 10mg. The subject lots of Atorvastatin Calcium Tablets, 10 mg were manufactured by Ranbaxy at its facility, A-41, Mohali, Punjab, India.

In August 2012, Ranbaxy had initiated a recall of a lot of Atorvastatin tablets 10 mg, based on receipt of a product complaint wherein an Atorvastatin 20 mg tablet was discovered by a pharmacist in a 90 count bottle of Atorvastatin 10 mg tablets. During a subsequent review of that market complaint and associated investigations, two other Atorvastatin 10 mg lots (2407255 and 2407256 – both packaged in 90s count bottles) have been identified wherein there could be a possibility of an Atorvastatin 20 mg tablet(s) getting packaged in these bottle packs. Till date, we have not received any such complaint for these lots, which will expire in May 2014. However, keeping the health and safety of our customers in mind, Ranbaxy has decided to voluntarily recall these two lots of Atorvastatin Calcium Tablets, 10mg (Lot# 2407255 and 2407256) which were packaged entirely in 90's count bottles.

This recall is being carried out to the retail level and is being conducted with the full knowledge of the FDA.

Please examine your inventory and quarantine any product pertaining to:

1. Immediately cease distribution of the drug product from the affected lot and remove it from active inventory.


